DALLAS--(BUSINESS WIRE)-- **Primoris Services Corporation (NASDAQ Global Select: PRIM)** ("Primoris" or "Company") today announced an underground award valued at approximately \$18 million. The contract was secured by Primoris Energy Services' Primoris Pipeline, part of the Energy segment.

- The award is for the installation of 82 miles of 12" liquid natural gas ("LNG") pipeline and one pump station in West Texas for a large midstream energy services provider.
- Construction is scheduled to start in the first quarter of 2016 and is expected to be completed in the third quarter of 2016.
